

# WRIA 10/12 CAC/TAG

## Meeting Summary

May 7, 2009, 4:00 to 6:00pm  
Tacoma Mall Office Building

### 1) Updates and Information Sharing

- a) April 9<sup>th</sup> Watershed Leads Conference Call – No WRIA 10/12 projects were included in the governor's Puget Sound economic stimulus funding list; a 6% reduction in funding for the lead entity is expected for 2009-10 fiscal year [*this was since restored by the SRFB*]; project sponsors who are receiving HETA assistance from WDFW need to schedule their project requests with WDFW staff; and the EPA grants to watersheds (\$50,000) will be available again through Ecology.
- b) Budget - \$33 million approved for PSAR – this amount includes capacity grants; we expect approximately \$2.1 million in project funding for the 2009-2010 rounds.
- c) The Lead Entity Program is being transferred from WDFW to Recreation and Conservation Office (RCO).
- d) Site visits are scheduled for July 8 & 9 with the SRFB Science Review Panel. The number of projects submitted will determine the number of days needed (one or two).

### 2) CAC/TAG Officers

Action: Kristin Williamson was elected vice-chair for the upcoming round by consensus.

### 3) 2009 3-Year Project List

- a) Narrative was revised to clarify:
  - i) Sequencing versus timing
  - ii) How strategy intersects with List – (Long term versus near term priorities)
  - iii) Comments taken until May 13. Bob agreed to send comments to Lorin by early next week.
  - iv) Background data, such as number of fish returning, should be updated.
  - v) The narrative (including Bob's proposed additions was approved by consensus.
- b) 3-Year List and narrative will be reviewed by the PS Partnership and the RITT – the RITT's priority is Puget Sound Recovery with a Chinook focus
- c) 3-year Project List Matrix
  - i) Stimulus projects submitted by Pierce County that asked to be on the list, but weren't funded, have been dropped from the 3-year project list.

- ii) There was discussion about the need to removed stalled projects that have been on the list for some time without progress; the CAC will take a closer look at this issue next year.
- iii) List should be modified to more realistically reflect the number of projects that can be completed in 3-years based on our typical funding.
- iv) Calistoga culvert replacement – will follow up with Pierce County about possible removal. Ken indicated this is being addressed by Orting. addressed
- v) TAG needs to review new projects; there are about 10 new write-ups for projects that have not been reviewed and ranked/tiered by the TAG.
- d) 3-year project list matrix approved by consensus.
- e) Future 3-Year List considerations and suggestions:
  - i) Development of projects to address steelhead listing
  - ii) Pre-spawn mortality findings in urban streams and proposals for Clover Creek – may need to develop a broad-based stormwater treatment program for WRIA 12
  - iii) Electron Dam fish screen – Habitat Conservation Plan process needed as well as a study of fish mortality; project is expected to last at least 3 years.
    - (1) Tribe has prepared a document addressing downstream fish passage improvement concepts and WDFW has been funded to study fish passage at the dam and make recommendations on improvements.
  - iv) Coho emphasis for WRIA 12 – Chum aren't even mentioned in the strategy
  - v) Updates to WRIA 10/12 Recovery Strategy – should probably be updated on about a 3-year cycle, with 2011 being the next update.

#### **4) Allocation of PSAR Funds in 2009 and 2010 Rounds**

- a) Options
  - i) Allocate all \$ in 2009 round
  - ii) Split funding evenly between 2009 & 2010 rounds
  - iii) Allocate at least half in 2009 with the option of adding more if we receive a lot of great projects exceeding a certain threshold in CAC and TAG scoring
- b) Possibilities – rank projects for this year and next year at same time
- c) The CAC decided to let sponsors know the range of funding that might be available and make decision on final allocation based on the quality of project submittals; the CAC decided against establishing a scoring threshold
- d) We expect to see a range of 7-10 project submitted this round

- a) Notice of Intent statements for proposed projects due on May 22<sup>nd</sup>.
- b) Both rooms will be reserved for June meeting
- c) TAG meetings and field trips cancelled for May.
- d) May schedule a field trip to view completed projects.
