Applicants proposing to do any sewer work on commercial property and/or are required to pay Sewer Connection Charges must complete, sign and submit this Residential Sewer Service Permit Application form.

- All new and existing businesses making new connections to the sewer system must also apply for a Pretreatment Review.
- You must also submit a Sewer Site Plan with this application (unless this is an application to pay Sewer Connection Charges only). See [Bulletin B17](#) for details that must be shown on the Sewer Site Plan.
- Applicants in unincorporated Pierce County may submit a "combined" Site Plan as required by Planning & Public Works.
