A site plan, which includes the following information, must accompany this application per Pierce County Code, Title 18H, Development Regulations-Forest Practices, Subsection 18H.20.060

- Harvest boundaries and tree retention areas;
- The approximate location of any existing structures;
- The locations of all existing and proposed street, rights-of-way, easements, skid roads, haul roads, and landings;
- The location of future land development such as a building site, septic drain field areas and/or well;
- Site topography at a contour interval of 40 feet;
- Critical areas and critical area buffers regulated pursuant to Title 18E-Critical Areas;
- Drainage ways; and
- North seeking arrow and scale shall be shown on all site plans. The scale shall be no smaller than one inch to 200 feet.

The following features must be clearly identified on the ground with flagging or colored paint. Please include how the following are to be identified.
