However, our live-aboard status wasn't confirmed until June 1st (we were waiting for our slip to be available permanently), hence the PO Box in Puyallup (it was close to work and we could grab the mail quick). As an aside, I am not sick of Puyallup, we had some great years here. It has its issues as does Tacoma, but we have had a goal of living on the water for some time and were able to accomplish that....thanks again.

Mr McGregor,

Do you have any comment regarding your legitimacy to vote in either the 25th legislative district or the city of puyallup.

According to the county assessor you and your wife sold your puyallup home in September 2018 and you chose to continue getting puyallup ballots by having them mailed to a puyallup po box. You list your residence as the house you sold. You and your spouse also voted in the November 2018 election.

This is confusing as you made several public announcements on social media that you were sick of puyallup and were leaving the city to live on a boat in tacoma. You also made it public that you were resigning positions on a city commission as you were leaving the city as you were no longer qualified.

Can you explain these anomalies with regard your actual residence, your registration and on what basis did you vote in last November's election which impact not only elected officials but also tax levies for a city where apparently you no longer reside. You state publicly that you live in Tacoma.

According to the county auditor, you still claimed your nw puyallup residence as of last week.

Apologies for sending this to your work email but you left no alternative. But as a proponent of transparency and legitimacy of the electoral process, these matters need to be addressed.

VOTER REGISTRATION CHALLENGE TO PAT & CANDICE MCGREGOR

In the 3rd quarter of CY2018, Pat and Candice McGregor sold their downtown Puyallup residence and moved to live on a boat in Tacoma. It was a high profile move as McGregor had run unsuccessfully for city council a couple of years prior and was a current planning commission member and resigned as he was moving out of Puyallup.

The Assessors Office shows their Puyallup home was sold in September 2018.

McGregor has also been active on social media reporting on his new lifestyle living on a boat in Tacoma in Commencement Bay.

I procured a copy of the voter registration database in late May 2019 for both the City of Puyallup and the 25th Legislative District. I saw that the McGregors were claiming their "sold house" as their residence and had their ballots delivered to a Puyallup PO Box. According to this database the McGregors have been voting in this district since vacating Puyallup probably on not just for individual candidates, but also tax levy issues.

I wrote this week to Pat McGregor at his work email address in the Puyallup School District to ask for an explanation. He replied, but the reply did not appear to address the issue of using his old address as the credential to remain a voter in Puyallup and the 25th District.

Attached are a copy of the McGregor's voting registration data, a screen shot of his FB page and the email conversation between Pat McGregor and myself.

Please investigate this issue. FYI, upon a more detailed review of the voter database, this is not an isolated case.

Dave,

Please find attached two Voter Registration Challenges for Pat and Candice McGregor. Both claim an address of a house they sold in September 2018 as the credential to maintain their voter registration in Puyallup. They have their ballots delivered to the Puyallup Post Office. They have since been residing on a boat in the Foss Marina in Tacoma according to social media. Pat McGregor complied with City rules by resigning from its Planning Commission in 2018 as he was no longer a resident.

Attached is also supportive material for this claim inclusive of Auditor Voter Registration data, Assessors sale record of the Puyallup residence, email correspondence between Pat McGregor and myself on the issue, screen dumps of Facebook pages showing residence on the boat in Tacoma etc etc.

If you have questions regarding this complaint, please contact me at either my icloud or comcast email address. (Apple have been experiencing unexplained technical issues for the past week if a email reply should bounce).

Sadly, this particular situation is not unique in Puyallup. Additional similar complaints of higher profile individuals will be submitted shortly.


