QUALIFICATIONS FOR DEPUTY SHERIFF

High School diploma or G.E.D. certificate. At least age twenty-one (21) at time of appointment. United States citizenship or lawful permanent resident at the time of application and the ability to read and write the English language as required by RCW 41.14.100. Ability to successfully complete Pierce County Sheriff's Department background investigation. Ability to pass the Washington State Criminal Justice Training Commission physical fitness requirements at time of entrance to the Academy. Entrance to and successful completion of the Basic Law Enforcement Academy is a condition of continuing probationary employment as required by RCW 43.101. Valid Washington State driver's license is required at time of appointment.

QUALIFICATIONS FOR CORRECTIONS DEPUTY

High School diploma or G.E.D. Certificate. At least age twenty (20) at time of appointment. United States citizenship or lawful permanent resident at the time of application and the ability to read and write the English language as required by RCW 41.14.100. Ability to successfully complete Pierce County Sheriff's Department background investigation. Must have a valid Washington State driver's license at time of appointment and be able to provide proof of insurability. Ability to pass the Washington State Criminal Justice Training Commission physical fitness requirements. Entrance to and successful completion of the Corrections Academy or Equivalency Academy is a condition of continuing as required by RCW 43.101.

AUTOMATIC DISQUALIFICATIONS

- Adult felony convictions
- Domestic Violence statute convictions
- Misdemeanor convictions within 3 years
- Pattern of criminal behavior
- Driving record exceeding allowable points within 36 months of application

Includes dismissed & expunged records

POTENTIAL DISQUALIFICATIONS*
